Acknowledgement & Acceptance of the Booking Terms and Conditions issued by KJ Events/Atlas Cruise & Tours. Set forth below are the Booking Terms and Conditions issued by KJ Events/Atlas Cruise & Tours and applies to each guest on the cruise, as set forth by *KJ Events/Atlas Cruise & Tours*. By completing a reservation, guest knowingly agrees to be bound by and accepts these terms as stated below and as may be amended from time to time. Such modifications and amendments to have the same force and effect as those set forth below. Failure to accept *KJ Events/Atlas Cruise & Tours* Booking Terms and Conditions in the time frame and manner determined by KJ Events/Atlas Cruise & Tours to cancel Guest's reservation without a refund.

Acknowledgement & Acceptance of the Booking Terms & Conditions Issued by Celebrity Cruises: Upon completion of either the Celebrity Cruises Online Check-In Procedure or upon completion of such check-in procedure at the cruise terminal Guest also expressly agrees to be bound by and accepts the Booking Terms & Conditions of Celebrity Cruises described in its Tour Ticket Contract. Failure to accept Celebrity Cruises Booking Terms & Conditions in the time frame and manner determined by Celebrity Cruises entitles Celebrity Cruises to cancel Guest's reservation without a refund.

**Conflict Between Booking Terms & Conditions Issued by KJ Events/Atlas Cruise & Tours and Celebrity Cruises**. Please note that the payment dates, reservation changes, reservation, and cancellation policies, set forth in *KJ Events* Terms and Conditions at the time of purchase supersede those policies set forth in the Celebrity Cruises Cruise/Tour Ticket Contract.

**Changes and Modifications to Booking Terms & Conditions**. KJ Events/Atlas Cruise & Tours and Celebrity Cruises Booking Terms & Conditions are subject to change at any time. With that said, such alterations and changes shall have the full force and effect as a term and condition issued at the time of booking or completion of registration as applicable.

**Cruise Cost:** Cruise Costs are based upon double occupancy unless designated as a "Single". Our fare includes all the usual amenities, accommodations and services outlined, in the Stateroom Description for the Category of Stateroom Guest has selected, together with government taxes, fees & exclusive live performances and onboard events produced by KJ Events/Atlas Cruise & Tours. Cruise Costs do not include the cost for any airfare, ground transportation, travel insurance, onboard purchases of goods and services (including, but not limited to alcoholic, spa services, gifts, or any such goods and services for which the Cruise Line customarily charges a separate fee), medical expenses, and shore excursions. Additional Cruise Costs are charged for 3rd and 4th Guests in a stateroom. The Cruise Costs for 3rd and 4th Guests may have different inclusions and exclusions as stated above. Port Charges, Taxes & Gratuities: Each Guest is required to pay port charges, government taxes and fees, and

other charges due and payable to third parties which has already been included in the price of the Stateroom.

**Payment Obligations** Upon Completion of Booking: Upon completion of a booking, Guest is obligated to pay their Cruise Cost based on the occupancy they reserved set forth in the Booking and any additional purchases made directly with KJ Events/Atlas Cruises & Tours according to the payment schedule they selected. If the booking is shared by more than one Guest, each Guest shall have full financial responsibility for their portion of the Cruise Cost unless in the case of minors, where that responsibility lies with the parent or legal guardian who is also traveling. Each guest must register themselves on our website <a href="https://groups.atlastravelweb.com/join/020925/overview">https://groups.atlastravelweb.com/join/020925/overview</a> and they must indicate who the name of the person they are rooming with in the Requested field. It is important that the name submitted matches identically to the way it was registered to us in order for the system to pair both parties accurately.

**Obligations of the Primary Guest**: The Guest that initiates the Reservation is considered the "Primary Guest" and is the "primary point of contact" of the Reservation. Although efforts are made to notify each guest individually, there may be times in which the Primary Guest will be the only one notified and it is their responsibility to disseminate the information as needed.

**Payment Plan Options:** KJ Events/Atlas Cruise & Tours has various ways to pay off your cruise including Payment Plans. By choosing a Payment Plan, KJ Events/Atlas Cruises & Tours will not automatically process payments on their respective due dates, those transactions must be initiated by each Guest by either logging into their KJ Events/Atlas Cruises & Tours account or by calling a vacation specialist at our contact center. However, you have authorized KJ Events/Atlas Cruises & Tours to charge the Guest's Credit Card or other method of payment in accordance with the payment schedule of the selected Payment Plan.

**Method of Payment:** If paying by credit card, Guest's account will be charged within 48 business hours from which the request was received, and Guest's statement will reflect a charge from "Atlas Cruise or Atlas Travel." Check payments are not allowed at this time. To make payments with PayPal, Guests should log into their reservation online and manually process each payment when due.

**Currency**: Unless otherwise noted, all prices on the website and any fees associated with the Cruise are quoted in United States Dollars ("USD"), and all payments to KJ Events/Atlas Cruises & Tours will be charged in USD. International Guests may incur additional fees assessed by their bank or credit card processor.

**Credit Cards/Cancellation Fees:** KJ Events/Atlas Cruise & Tours reserves the right to assess additional penalties for returned, late or missed payments, canceled cards, chargebacks, credit card changes, invalid credit cards, and cancellations as a result of a Guest's failure to adhere with these Booking Terms and Conditions.

**Non-Refundable Payments — Refund Events:** Except as set forth in this section, all Total Cruise Cost payments made to date or paid in the future are non-refundable. Payments are refundable only when either Celebrity Cruises or KJ Events/Atlas Cruises & Tours cancels or reschedules the cruise ("Refund Events"). If so desired, eligible Guests will be included in the applicable Refund Event Refund Program which will outline the procedure and process for receiving a refund. Guests may otherwise elect to continue their reservation with the rescheduled cruise without any increase in Cruise Costs that were to have been available to them if this subject cruise had sailed. By accepting the terms and conditions for a non-refundable trip you are waiving your right to deny charges on your credit card at a later date.

**Health Restrictions:** Guest agrees to comply with any and all health restrictions imposed by Celebrity Cruises, KJ Events/Atlas Cruises & Tours, the Centers for Disease Control and Prevention or any other governmental agency or body with jurisdiction over this Cruise Program. Guest is responsible for providing any information requested and for clearing any pre-cruise health, safety or travel requirements or limitations, regardless of when issued or applied including, but not limited to, evidence of full vaccination with a vaccine that is fully approved or authorized for emergency use by the Food and Drug Administration or the World Health Organization, negative test results for COVID-19, testing performed in the Cruise Terminal prior to boarding, on the ship, in ports, or at any other time during the cruise. Denial of boarding due to failure to adhere to the above is not a Refund Event (see below).

# **Right to Modify or Cancel Cruise:**

• Right to Modify Cruise: KJ Events/Atlas Cruises & Tours modify itineraries, entertainment, line up and

schedules, change onboard entertainers and schedules, modify amenities, and/or delay or change departures or arrivals without any further obligation to Guest and any such change or modification shall not be a Refund Event.

• Right to Cancel a Reservation or Deny Boarding: KJ Events/Atlas Cruises & Tours reserves the right to cancel a reservation at any time at its sole discretion, and/or to deny boarding or refuse service to any person for any reason and shall not be considered a Refund Event.

• Right to Cancel Cruise: KJ Events/Atlas Cruises & Tours reserves the right to cancel the cruise for any reason. Such cancellation shall be a Refund Event (see, below). **Travel Insurance/Trip Protection:** 

• Purchase is Strongly Encouraged: As all Cruise Cost payments to KJ Events/Atlas Cruise & Tours are non-refundable, Guests are strongly encouraged to purchase Travel Insurance/Trip Protection, which can insure against many, but not all, of the causes of forfeiture of payments. **Name Changes**: Name changes made to any Reservation will be assessed a \$75 administrative fee. At least one original and/or Guest name must remain on the Reservation. If all original Guests cancel, this is considered a full cancellation without a refund, and name changes will not be allowed.

**Transfer of Reservation:** If none of the original Guests on a Reservation are able to sail, said Guests may transfer their reservation to another Guest(s), subject to the following conditions: a one-time, non-refundable transfer fee of \$250 pp; and no objection received from Celebrity Cruises. New Guests are subject to the Cruise Costs on the day of transfer, transfer of Reservation does not include past guest, military or other discounts/offers from original Reservation. # Valid Identification/Passports and Visas:

• U.S. Citizens: U.S. Citizens are strongly urged to travel with a valid passport with at least six (6) months validity remaining after the final day of the cruise. For voyages that begin and end in the same U.S. Port, U.S. Citizens may travel without a passport but may do so only if they present both a Government-issued birth certificate and Government-issued

• Non-U.S. Citizens: All Non-U.S. Citizens must present a valid passport to board the ship. Though not required, such guests are urged to travel with a valid passport with at least six (6) months validity remaining after the final day of the cruise. Depending upon the citizenship of each Guest and the passport governing their travel, Guests may need to apply for and secure a visa to enter various ports of call.

• Change in Applicable Rules: The above requirements are required by government regulations and policies. They are subject to change without notice.

• Responsibility of Guests: The Guest is responsible for identifying and obtaining all required travel documents and have them available at the terminal or wherever

necessary for their entire cruise vacation. These appropriate valid travel documents such as passports, visas, inoculation certificate and family legal documents are required for boarding and re-entry into the United States and other countries.

• Denial of Boarding: If a Guest does not possess the proper documentation, then Guest may be prevented from boarding a flight or ship, from entering a country, and may be subject to fines. Neither failure to provide proper and required documentation or being denied board for any reason whatsoever are Refund Events.
